Notice is given that the **Annual General Meeting (Meeting)** of Sunbridge Group Limited (**Company**) will be held at the offices of Grant Thornton, King George Central, Level 18, 145 Ann Street, Brisbane, QLD 4000, Australia on Monday 18 May 2015 commencing at 10:00am AEST. Further details of each item of business to be considered at the Meeting are set out in the Explanatory Statement. Definitions of capitalised terms used in the Notice of Meeting and Explanatory Statement are set out in Definitions section of the Explanatory Statement.

**Financial Report, Directors' Report and Auditor's Report**

*To receive and consider the Financial Report of the Company, together with the Directors' Report and the Auditor's Report, for the year ended 31 December 2014 as set out in the **Annual Report**.*

**Resolution 1 – Adoption of Remuneration Report**

To consider and, if thought fit, to pass, the following resolution as a **non-binding ordinary resolution**:  
*"That, for the purpose of section 250R(2) of the Corporations Act and for all other purposes, approval is given for the adoption of the Remuneration Report as contained in the Annual Report."*

**Note: the vote on this Resolution is advisory only and does not bind the Directors or the Company.**

**Voting exclusion:**

A vote on this Resolution must not be cast (in any capacity) by or on behalf of any of the following persons:

- (a) a member of the Key Management Personnel; or
- (b) a Closely Related Party of such a member. However, a person (the voter) described above may cast a vote on this Resolution as a proxy if the vote is not cast on behalf of a person described above and either:
- (c) the voter is appointed as a proxy by writing that specifies the way the proxy is to vote on the Resolution;  
or
- (d) the voter is the Chair and the appointment of the Chair as proxy:
  - (i) does not specify the way the proxy is to vote on this Resolution; and
  - (ii) expressly authorises the Chair to exercise the proxy even if the Resolution is connected directly or indirectly with the remuneration of a member of the Key Management Personnel for the Company, or if the Company is part of a consolidated entity, for the entity.

**Resolution 2 – Re-election of Mr Benny Qiu**

To consider and, if thought fit, pass as an **ordinary resolution**:  
*"That Mr Benny Qiu, who retires in accordance with clause 11.4(b) of the Company's constitution and, being eligible, offers himself for re-election, be elected as a Director of the Company."*

**Resolution 3 – Re-election of Mr Wayne Reid**

To consider and, if thought fit, pass as an **ordinary resolution**:  
*"That Mr Wayne Reid, who retires by rotation in accordance with clause 11.1(c) of the Company's constitution and, being eligible, offers himself for re-election, be elected as a Director of the Company."*

**Resolution 4 – Re-election of Professor QiangAn Liu**

To consider and, if thought fit, pass as an **ordinary resolution**:

*"That Professor QiangAn Liu, who retires by rotation in accordance with clause 11.1(c) of the Company's constitution and, being eligible, offers himself for re-election, be elected as a Director of the Company."*

## **INFORMATION FOR SHAREHOLDERS**

These notes and the Explanatory Statement form part of the **Notice of Meeting**.

### **EXPLANATORY STATEMENT**

The accompanying Explanatory Statement forms part of this **Notice of Meeting** and should be read in conjunction with it. Definitions section of the Explanatory Statement contains definitions of capitalised terms used in this Notice of Meeting and the Explanatory Statement.

### **REQUIRED MAJORITIES**

Resolutions 1, 2 and 3 are ordinary resolutions. An ordinary resolution requires a simple majority of votes cast by Shareholders present (in person, by proxy or representative) and entitled to vote on the resolution.

### **ENTITLEMENT TO VOTE**

The Directors have determined that, for the purpose of voting at the Meeting, Shareholders are those persons who are the registered holders of Shares at 7.00pm (AEST) on Friday 15 May 2015.

### **HOW TO VOTE**

You may vote by attending the Meeting in person or by proxy, attorney or authorised representative.

### **VOTING IN PERSON**

To vote in person, attend the Meeting on the date and at the place set out in the Notice of Meeting.

### **APPOINTMENT OF PROXIES**

A Shareholder who is entitled to attend and vote is entitled to appoint a proxy to attend and vote at the Meeting. A Shareholder entitled to cast two or more votes may appoint one or two proxies and may specify the proportion of votes each proxy is appointed to exercise. If the Shareholder appoints two proxies and the appointment does not specify this proportion, each proxy may exercise half of the votes. A proxy may be, but need not be, a Shareholder and can be an individual or a body corporate. **Your proxy form is enclosed.**

A body corporate appointed as a proxy may appoint an individual as its representative to exercise any of the powers the body corporate can exercise as a proxy at the Meeting. The representative should bring to the Meeting evidence of his or her appointment, including any authority under which the appointment is signed, unless it has previously been given to the Company.

#### **BODIES CORPORATE**

A body corporate may appoint an individual as its representative to exercise any of the powers the body corporate may exercise at meetings of the Company's Shareholders. The appointment may be a standing one. Unless the appointment states otherwise, the representative may exercise all of the powers that the appointing body corporate could exercise at a meeting or in voting on a resolution.

The representative should bring to the meeting evidence of his or her appointment, including any authority under which the appointment is signed, unless it has previously been given to the Company.

## EXPLANATORY STATEMENT

### INTRODUCTION

This Explanatory Statement has been prepared for the information of Shareholders in relation to the business to be conducted at the Meeting. This Explanatory Statement should be read in full and in conjunction with the Notice of Meeting. Capitalised terms in this Explanatory Statement are defined in Definitions section of this Explanatory Statement. You should consult with your professional advisers if you have any questions in relation to how to vote on the Resolutions. There are resolutions to be put in the Meeting. Certain voting exclusions are imposed by the Listing Rules and the Corporations Act in relation to the Resolutions as detailed in the accompanying Notice of Meeting.

### FINANCIAL REPORT, DIRECTORS' REPORT AND AUDITOR'S REPORT

The Corporations Act requires the Company to lay before the Annual General Meeting the Financial Report, Directors' Report (including the Remuneration Report) and the Auditor's Report for the financial year ended 31 December 2014. No resolution is required for this item, but Shareholders will be provided with a reasonable opportunity to ask questions or make comments in relation to these reports. The Company's auditor will also be present at the meeting and Shareholders will be given the opportunity to ask the auditor questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies adopted by the Company and the independence of the auditor.

### RESOLUTION 1 – REMUNERATION REPORT

#### General

The Corporations Act requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the Directors or the Company. The remuneration report sets out the Company's remuneration arrangements for the Directors and senior management of the Company. The remuneration report is part of the Directors' report contained in the Annual Report of the Company for the financial year ending 31 December 2014. A reasonable opportunity will be provided for discussion of the remuneration report at the Annual General Meeting.

#### Proxy Restrictions

Shareholders appointing a proxy for Resolution 1 should note the following:

#### ***If you appoint a member of the Key Management Personnel as your proxy***

if you elect to appoint a member of Key Management Personnel or a Closely Related Party of that member, ***you must direct the proxy how they are to vote***. Undirected proxies granted to these persons will not be included in any vote on Resolution 1.

#### ***If you appoint the Chair as your proxy***

if you elect to appoint the Chair as your proxy, you ***do not*** need to direct the Chair how you wish them to exercise your vote on Resolution 1, however if you do not direct the Chair how to vote, ***you must tick the acknowledgement on the proxy form to acknowledge that the Chair may exercise their discretion in exercising your proxy even though Resolution 1 is connected directly or indirectly with the remuneration of Key Management Personnel***.

#### ***If you appoint any other person as your proxy***

You ***do not*** need to direct your proxy how to vote, and you ***do not*** need to tick any further acknowledgement on the proxy form.

The Board of Directors unanimously recommends that Shareholders vote in favour of Resolution 1.

## **RESOLUTION 2 – RE-ELECTION OF MR BENNY QIU AS A DIRECTOR**

Clause 11.4(a) of the Company's constitution provides that the Directors may at any time appoint any person to be a Director, either to fill a casual vacancy or as an addition to the existing Directors, but so that the total number of Directors does not at any time exceed the maximum number of Directors specified by the Constitution. Clause 11.4(b) of the Company's constitution provides that any Directors so appointed holds office only until the next general meeting and is then eligible for re-election.

In accordance with the above, Mr Benny Qiu retires at the Meeting and, being eligible, offer himself for re-election as a Director.

Mr Benny Qiu has over 30 years of experience in corporate finance, business management and international business across different industries, including manufacturing, real estate services, investment and financial services.

The Board of Directors (excluding Mr Benny Qiu) unanimously recommends that Shareholders vote to in favour of Resolution 2.

## **RESOLUTION 3 AND 4 – RE-ELECTION OF MR WAYNE REID AND PROFESSOR QIANGAN LIU AS A DIRECTOR**

Clause 11.1(c) of the Company's constitution provides that at each annual general meeting one-third of the Directors for the time being and any other Director not in such one-third who has held office for 3 years or more (except the Managing Director) must retire from office, but a Director who retires under this clause is eligible for re-election at that meeting. A Managing Director is not required to retire by rotation in accordance with clause 13.22 of the Company's constitution.

Mr Reid has served on a Federal Government advisory board, was president of Tennis Australia and the Melbourne Football Club and is a Member of the Australian Sporting Hall Of Fame. He has been a Director on over 30 company boards of various companies across several continents in diverse and wide ranging industries, including insurance, pharmaceutical, retail, mining, stock-broking, construction, property development and hospitality.

Prof. Liu holds a Doctorate in Accountancy and participates in post doctorate research in Peking University. Prof. Liu is presently the chairing professor in the entrepreneurship development program in Xiamen University. Prof. Liu possesses extensive practical experience in corporate financial management, enterprise management information system implementation, internal controls and capital operations.

The Board of Directors (in each case excluding the relevant candidate) unanimously recommends that Shareholders vote in favour of Resolution 3 and 4.

**Article** means an article of the Constitution.

**Auditor's Report** means the auditor's report on the Financial Report.

**Board** means the board of Directors.

**Business Day** means Monday to Friday inclusive, except New Year's Day, Good Friday, Easter Monday, Christmas Day, Boxing Day, and any other day that the ASX declares is not a business day.

**Chair or Chairman** means the person appointed to chair the meeting of the Company convened by this Notice.

**Closely Related Party** of the Key Management Personnel means:

- (a) a spouse or child of the member;
- (b) a child of the member's spouse;
- (c) a dependent of the member or the member's spouse;
- (d) anyone else who is one of the member's family and may be expected to influence the member, or be influenced by the member, in the member's dealing with the entity;
- (e) a company the member controls; or
- (f) a person prescribed by the Corporations Regulations 2001 (Cth).

**Company** or **Sunbridge** means Sunbridge Group Limited (ACN 163 886 020).

**Constitution** means the Constitution of the Company as at the date of the Meeting.

**Corporations Act** means the Corporations Act 2001 (Cth).

**Directors** mean the directors of the Company.

**Directors Report** means the annual directors report prepared under Chapter 2M of the Corporations Act for the Company and its controlled entities.

**Explanatory Statement** means this explanatory statement.

**Financial Report** means the annual financial report prepared under Chapter 2M of the Corporations Act of the Company and its controlled entities.

**Key Management Personnel** means a person having authority and responsibility for planning, directing and controlling the activities of the Company, directly or indirectly, including any Director (whether executive or otherwise) of the Company.

**Listing Rules** means the listing rules of ASX.

**Meeting** has the meaning given in the introductory paragraph of the Notice.

**Notice** means the Notice of General Meeting which this Explanatory Statement accompanies.

### TO VOTE BY COMPLETING THE PROXY FORM

#### STEP 1 APPOINTMENT OF PROXY

Indicate who you want to appoint as your Proxy.

If you wish to appoint the Chair of the Meeting as your proxy, mark the box. If you wish to appoint someone other than the Chair of the Meeting as your proxy please write the full name of that individual or body corporate.
